## GENERAL TERMS AND CONDITIONS FOR ADULT UPHOLSTERY WORKSOPS 2024.

### Terms established on February 1, 2022

1. These General Conditions of Sale, hereinafter referred to as "GTC", are concluded between: Céline Vanier - whose head office is located at 58 route d'Annecy 74290 Veyrier du Lac and registered under the siret number **78875231900038** and **training organization registered under the number declaration of activity 84740408674** , hereinafter referred to as "the management" and between any natural or legal person who has registered for a tapestry course in 2023 and / 2024 provided by Céline Vanier – Tapisserie and Decoration, hereinafter referred to as "the trainee".
2. All informations and prices of the courses are indicated on the information mail you will received by mail when you contact us for more informations.
3. The trainee undertakes to respect these GTC throughout the course for which he / she is registered. by submitting the application form and/or making payment you confirm that you have read and understood these General Conditions.
4. For the smooth running of the course, each trainee undertakes to respect the schedules and therefore to ensure that they do not arrive late.

5. The minimum age required to register for one of the courses is 18 years old. Some very rare exceptions can be made, with parental authorization written and signed by the parents.
6. Each trainee must notify in writing any change in personal information before the start of the workshop.
7. To validate their registration and ensure their place, the trainee must complete the full payment before the class .
8. The payment must be done at least 30 days before the start of the course Unless it's a last minute offer .

10. The price of each course does not include accommodation, transport, meals, clothing or equipment, nor any other personal expenses. Outings and leisure activities outside of class hours are at the initiative and expense of the trainees.
11. The following different payment methods are accepted: cheque or bank transfer (at least 30 days before the beginning of the course), online payment by credit card with Paypal if you prefer (with 10 % extra charges). No other payment method will be accepted.
12. Any registration not confirmed by a bank transfer or an online payment will be cancelled.
13. Due to the nature of preparation involved prior to a course commencing **we are unable to offer refunds on cancellations** . For a eventual date exchange or replacement with another trainee, please contact the management. We are always looking for solutions.

No refund of the upholstery course (neither deposit nor full amount) can be made to the trainee in the event of absence, withdrawal, abandonment, cancellation, resignation, health problems, family problems, professional transfer or any other reason having led him to no longer follow the course, regardless of the date on which the trainee decides not to take the course.

The 2 exceptions to this are:

1. If the management cancels the course for any unforeseen circumstances a full refund be given within 30 days of the course cancellation or you may change the date of your course.
- 2- Covid 19 : In the event of a 'Lockdown' we will honour your booking and rearrange a class for the next date available. You will be emailed directly to the address used for booking to confirm these arrangements.

14. In the event of payment by cheque, if at the time of collection it is not supplied, the trainee must reimburse the bank charges incurred, and pay the amount of the check within 7 days.

15. Each trainee commits to the entire workshop. Once registration is taken, the entire course is due.
16. Accommodation is not included, the rates for accommodation and/or full board are set by the owners of the places that host us. They are independent, the trainees then pay directly to these service providers. Céline Vanier declines all responsibility with regard to the provision of external services (accommodation, meals, transport).
17. The management does not assume responsibility in the event of theft, damage or forgetfulness in the rooms where the upholstery courses take place, of any personal item of value or not. Access to the head office workshop is prohibited outside the hours of the sessions. The courses take place behind closed doors.
18. The trainee must have civil liability insurance and personal insurance for bodily injury covering his/her activity during the upholstery class in which he is participating. The trainee is therefore responsible for any damage he may cause to others or to equipment, whether during upholstery class, or outside class hours, whether in his room or in the dining room.
19. The trainee acknowledges being in good health and fit for the practice of upholstery, that is to say that his body does not hinder him to practice this activity. It should be able to move easily. Each trainee must report any health problems. Students should be aware that these courses require an element of lifting, carrying, bending and standing and that our workshop is on the first floor.
20. The management always reserves the right to change the content of the workshops and trainings and/or to change prices of futur workshops.
21. The management reserves the right to change the teacher initially scheduled if it is really necessary. No refund can be requested for this reason.
22. The Management reserves the right to exclude a trainee whose behavior would clearly harm the progress and balance of his group or the good atmosphere of the course.
23. The schedules of upholstery classes during the course are set by the tutor.
24. Benevolence is the fundamental values of this workshop also made to empower women in craftsmanship so let's show some love and respect.
25. Céline Vanier – Art des Etoffes undertakes to provide the performance of the services with all its care. On the other hand, its responsibility cannot be engaged in the event that the non-performance of its obligations is attributable to the contract in a case of force majeure (natural disasters, fires, attacks, general strikes, pandemics, etc.), as defined by French case law, or in the event of a serious accident of the upholstery teacher the day before the 1st day of the course. Similarly, Céline Vanier - Tapisserie et Decoration cannot be responsible when ordering online for any inconvenience or damage inherent in the use of the Internet network, in particular a break in service, external intrusion or the presence of computer viruses. .
26. We may wish to photograph or film the Workshop and reserve the right to do so for the purposes of promoting future workshops or otherwise. You consent to us (or any other person attending the Workshop) photographing or filming you and any persons attending the Workshop with you. You may not photograph or video the Workshop without our prior consent and of course we will respect yours as well.

27. It is common for tutors or the trainees to bring a snack to punctuate the breaks during class hours. Drinks, cakes or other, will in any case have an expiration date much higher than today's date. Céline Vanier – Tapisserie et Decoration declines all responsibility in the event of food poisoning.

28. If a participant were to fall ill, the management can in no way be held responsible for any contamination. Each participant is responsible for his own physical and psychological health and hygiene.

29. Out of respect for the other participants in the group, each trainee agrees to renounce any video, audio and visual (photo) recording on his part, during class hours, at the inside work rooms unless otherwise agreed.

30. The intern authorizes the management to communicate his or her contact details only to other trainee registered for the same internship as him. In accordance with the French law, the information collected and transmitted, as part of the registration of participants in the courses, may give rise to the exercise of the individual right of access and rectification with Céline Vanier, who does not market the information to third parties. data collected.

31. On the registration form, personal data such as surname, first name, postal and electronic address, date of birth, telephone number and others, will be processed and stored in accordance with the principles set out in the GDPR (General Regulation for the Protection of Data).

32. All content and educational materials used by the teacher to provide training or given to trainees constitute original works and as such are protected by intellectual property and copyright. As such, it is forbidden to use, transmit, reproduce, exploit these documents, without the prior consent of its author.

36. These GTC are expressly approved and accepted by the trainee, who declares and acknowledges having perfect knowledge of them, and therefore waives the right to rely on any contradictory document.

37.The GTC are subject to French law. In the event of a dispute relating to this Contract, whether it concerns its interpretation, its execution or its termination, Céline Vanier Tapisserie Décoration and the trainee will endeavor to settle the said dispute amicably prior to any legal action. justice. In the absence of a successful amicable resolution, the Commercial Court of Annecy will have jurisdiction according to the applicable rules of procedure.
